A portion of all profits goes to help fund local initiatives in Nicaragua.

A US\$500 deposit is required 60 days prior to the departure date. The remaining balance is due 30 days prior to the departure date. A 50% refund of the deposit will be refunded up until 30 days prior to the departure date. No refunds will be given within 30 days prior to the departure date.

Tour cost includes all ground and air transportation in Nicaragua, all excursion and entrance fees, English-speaking guides (Chinese (Mandarin) upon request), double occupancy accommodations, breakfasts, lunches and dinners. International airfare is **NOT** included and must be arranged by participant. Also **NOT** included are tips, alcoholic beverages, and airport taxes. ¡Un Buen Viaje! will arrange Managua airport pick up and drop off according to flight information supplied by participant. Tours require a minimum of 4 participants and are limited to 6. Exceptions can be made for private parties of 1-3.

TERMS & CONDITIONS

- 1) **BOOKING.** A deposit of US\$500 is due with registration 60 days prior to departure date. The remaining balance is due no later than 30 days prior to the departure date. No refunds will be given within 30 days prior to the departure date. Payments must be made by personal check or money order.

¡Un Buen Viaje! will accept a booking only after receiving a deposit of US\$500 and a completed registration form, including acceptance of the following terms and conditions, and issuing the participant his/her written confirmation. The remaining balance must be paid in full no later than 30 days prior to the departure date, or ¡Un Buen Viaje! may, at its sole option and without further notice to participant, treat the booking as canceled. Payments must be made by personal check or money order.

- 2) The Participant must separately arrange for travel to and from Nicaragua, and must carry a valid passport/visa where required. Participant will provide ¡Un Buen Viaje! with international flight details no later than 15 days prior to departure date.
- 3) ¡Un Buen Viaje! acts only as agent on behalf of the Participant in order to obtain for Participant the service of the contractor(s) providing accommodations, transportation, and other services. All receipts, tickets, vouchers, coupons, or exchange orders are issued subject to terms and conditions of the issuing entity and under which such transportation, hotel, or services are provided. The Tour may be cancelled at any time, even after Participant has departed the United States, for reasons beyond the control of ¡Un Buen Viaje! and ¡Un Buen Viaje! shall have no responsibility for any such cancellation. ¡Un Buen Viaje! shall have no responsibility to Participant for any inability to complete the Tour by reason of travel restrictions, travel delays, quarantines, medical or customs regulations, delays or cancellations of or changes in itinerary or schedules of carrier, or injury to or other inability of Traveler. ¡Un Buen Viaje! assumes no responsibility for actions or omissions by any contractor or other persons. Without limitation of the foregoing, by way of example only, ¡Un Buen Viaje! is not responsible for airline accidents, loss of luggage, injuries while riding any animal, non-motorized, or motorized conveyance, or other loss or damage. Participant agrees that, and expressly releases ¡Un Buen Viaje! from any and all liability for death, personal injury, loss, or damage of any cause that directly or indirectly relates to the Tour, including transportation arrangements to and from the Tour, for any reason or cause whatsoever, except willful, wanton and intentional conduct on the part of ¡Un Buen Viaje!.
- 4) The Participant must carry insurance against medical and personal accident risk. Your health insurance may not cover you for travel in a foreign country absent prior notice to the insurance company. It is Participant's responsibility and obligation to contract his/her insurance carrier prior to tour departure to confirm he/she is covered while on this Tour. Participant with travel with a complete understanding of his/her insurance policy and its procedures, and will keep documentation available at all times on the Tour.

It is recommended that the Participant also obtain trip cancellation insurance concerning travel arrangements and the Tour price. It is also recommended that Participant obtain insurance for his/her personal legal liability. Your homeowner's insurance policy may provide this coverage; check with your agent.



- 5) ¡Un Buen Viaje! reserves the absolute right to accept or retain any person as a tour participant.
- 6) ¡Un Buen Viaje! assumes no responsibility for alterations in tour schedule, delays, detentions, or cancellations caused by war or threat of war, civil strife, natural disaster, terrorist activity, industrial disputes, strikes, fire, inclement weather, sickness, act of government or public authorities, or any circumstance amounting to a force majeure and/or act of God.
- 7) Participant promises, represents, and warrants that he/she shall comply with all laws, rules, and regulations of the country and areas in which the tour takes place. ¡Un Buen Viaje! or its contractors operating the Tour reserves the right to reject and immediately terminate the participation in the Tour of any Participant for behavior endangering the safety or welfare of any Participant(s), including him or herself. No refund will be made to any participant who is so rejected and terminated from the Tour.
- 8) If any Participant on the Tour is a minor, his or her parent(s) and/or legal guardian must, shall, and hereby agrees to assume full responsibility for all expenses and liabilities of the Participant who is a minor. The Participant, on request of ¡Un Buen Viaje!, shall provide proof of age.
- 9) Participant hereby gives permission for any photograph, video, or any similar image obtained by any image capturing device or mechanism taken or acquired during the Tour to be used in any publication or promotional literature for ¡Un Buen Viaje!.
- 10) **CANCELLATIONS.** The Tour may be cancelled by us as set forth in sections 3, 4, 5, and 6. In the event of trip cancellation as set forth in sections 3, 4, 5, and 6, ¡Un Buen Viaje! will refund the Participant the Tour amount less a \$200 processing fee, but shall not be responsible for expenses incurred by the participant in preparation for the Tour, including but not limited to non-refundable airfare, passport fees, medical expenses, and other unidentified expenses.
- 11) This contract shall be governed by the laws of the State of Minnesota, which is the principal place of business of ¡Un Buen Viaje!. Participant hereby consents to, accepts, and subjects him or herself voluntarily to the jurisdiction of the Minnesota courts. Whenever possible, each provision of this agreement shall be interpreted in such a manner as to be effective, valid and enforceable under the laws of the State of Minnesota. However, if any provision of this agreement shall be prohibited by, or shall be invalid or unenforceable under the applicable law, such provision will be ineffective to the extent of such prohibition, without invalidating the remainder of such provision or the remaining provisions contained in this agreement.
- 12) This agreement contains the entire agreement between ¡Un Buen Viaje! and the Participant. There are no other oral or written agreements not contained within this agreement.

No single waiver of any term herein by ¡Un Buen Viaje! shall be deemed a waiver of that term in the future, nor shall such a waiver be deemed a waiver of other term herein.



No waiver shall be effective unless stated to be so expressly, in writing, specifying the particular term waived, and signed by both ¡Un Buen Viaje! and Participant.

Participant agrees that she/he shall indemnify ¡Un Buen Viaje! for all cost and attorney fees incurred by ¡Un Buen Viaje! in enforcing this Agreement or any part thereof.

Participant hereby certifies that Participant has read and understands the foregoing terms, conditions, and waivers, and Participant hereby accepts and agrees to be bound by the foregoing terms, conditions and waivers.
